2. Registered office:

- The head office of the Trust shall be stipulated at VPO Bilaspur, Tehsil Jagadhri distt. Yamuna Nagar in the state of a) Haryana. It may be shitted to any other place as decided by the managing committee from time to time.
- State level branch office (s) and sub-Branch office (s) shall be opened to run any where/within the territory of Indian Union.
- State level branch (s) office (s) and distt. Sub-office (s) shall function in accordance with the instruction issued from c) head office from time to time.

3. Area of Operation :-

Whole of India, especially state of Haryana .

4. Aims and objects:-

Lala Amarnath Educational Trust, is established for setting up of Educational institutions solely for educational and charitable purpose.

To work for upliftment of education i.e Technical, Higher Education, Professional Education and Medical/Health Education b) etc. and to promote and develop education, employment, science and technology and prosperity of humanity by way of incipal different educational, Research & Training anpati Convent School institutions. 

18. SUPPLEMENTARY PROVISIONS:

Auditing of accounts:

The accounts of the trust of all its branches and of all its institutions shall be kept separately and shall annually be audited by the charted auditor appointed by the Chairman with consolation of secretary. Such audited accounts shall be placed at the annual meeting of the Trust for its approval.

19. INVESTMENT OF FUNDS/AUDIT OF ACCOUNTS BANK ACCOUNT: -

The Trust may open one or more Bank Account(s). Chairman is autorized to operate the same jointly with Finance Secretary. All subscriptions, donations, grants and other monies of the trust shall be deposited in the Bank Accounts of the Trust.

20. ALTERATION IN RULES:

These rules and regulation may be amended and altered by the trust but the new rules and regulations shall not be inconsistent with or contrary to the aims and objects of these constitutions or the duties and powers reserved under these rules or any officer of authority of the Trust.

If any question arises whether any person has been duly elected or appointed is entitled to be member of any authorities or other body of the Trust, the matter shall be referred to the Governing body of the Trust whose decision there on shall be final.

All the properties (movable or immovable) by way of gift endowment, purchase or otherwise shall be acquired in the name of the Trust or as resolved and all such properties when so acquired shall vest in the Trust.

The Trustees reserve the right to purchase/sale land and or acquire building for its benefit or in the larger interest of the Trust.

In case of any dispute with the Trust or concerning the functioning of the Trust for any kind of dispute, which pertains to the Trust would be referred for arbitration with the 2/3rd majority of the managing committee members.
